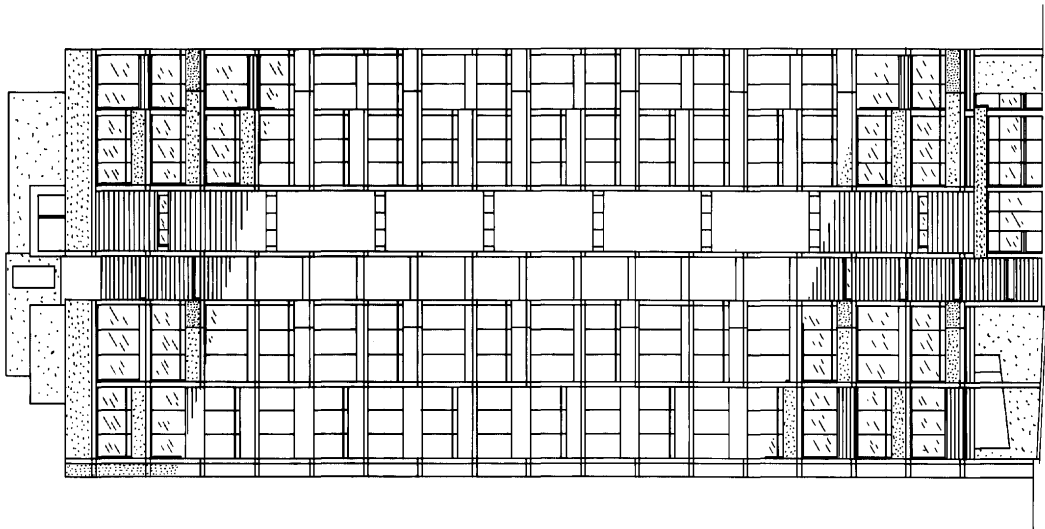

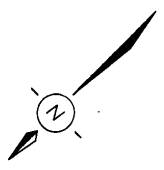

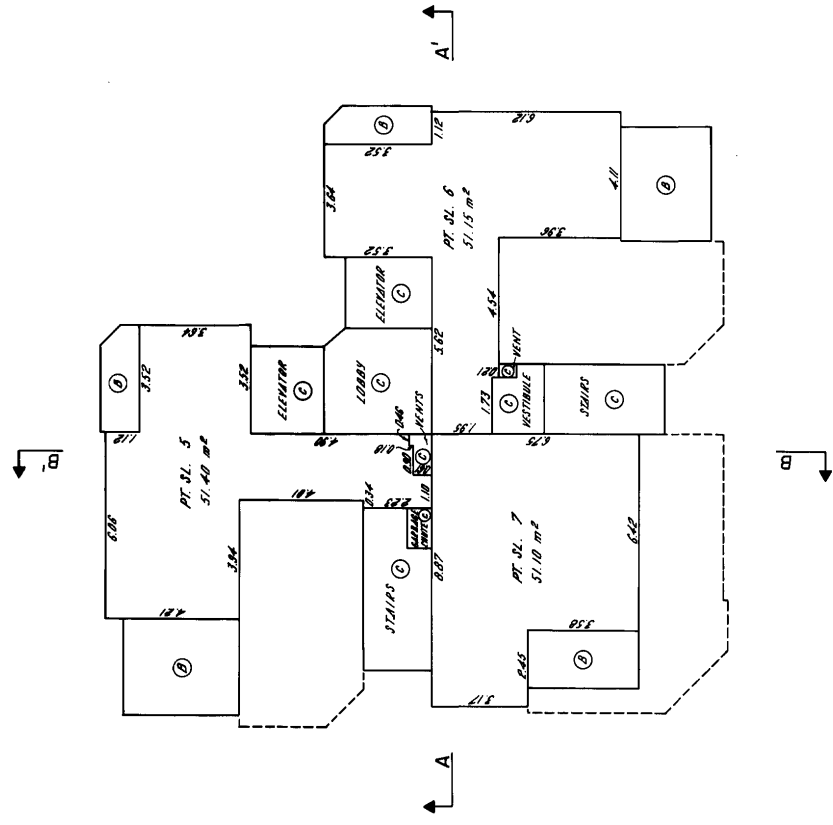
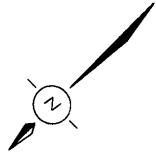
## THIRD FLOOR FLOOR PLAN SCALE: 1:125





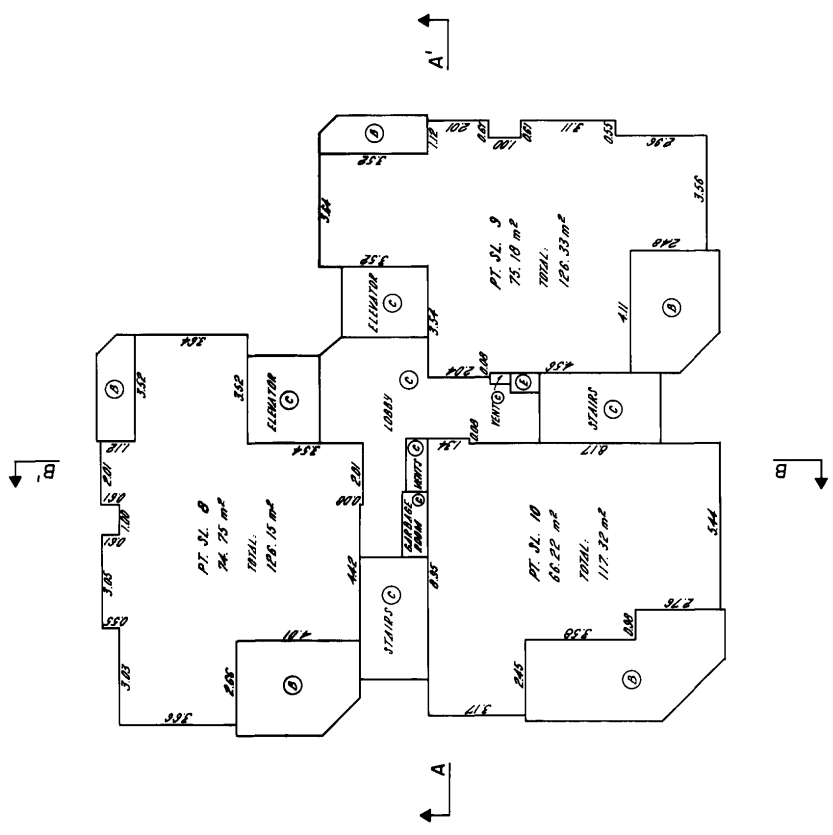
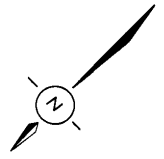

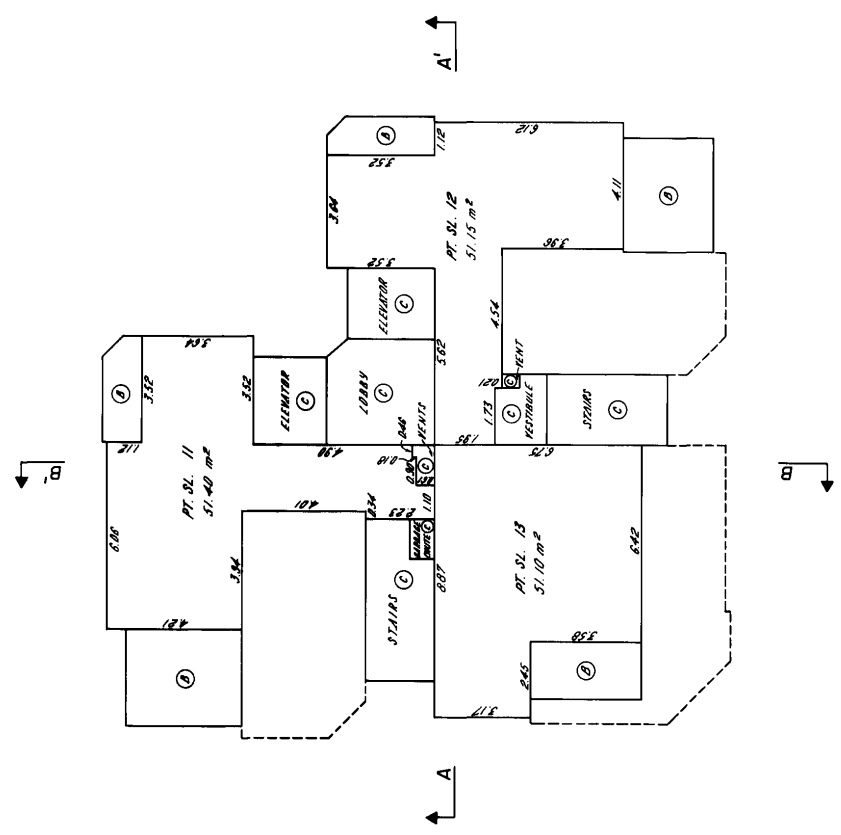
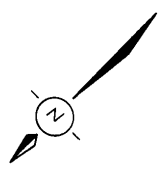
## EIGHTH FLOOR FLOOR PLAN

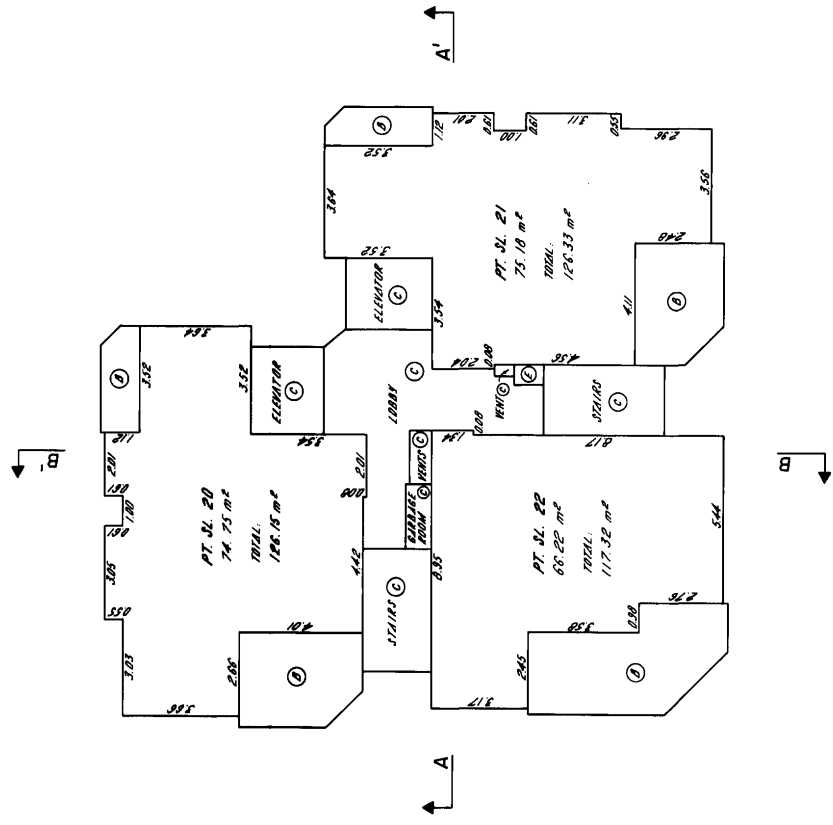
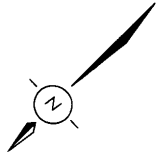


STRATA PLAN **Vr 457**
